

**MINUTES OF THE LYMAN TOWN COUNCIL MEETING
LYMAN MUNICIPAL COMPLEX
August 6, 2012**

1. CALL TO ORDER:

The regularly scheduled meeting of the Lyman Town Council was called to order by Mayor Pro tem Tony Wyatt at 6:30 PM.

Police Department –

Fire Department –

Public Works –

Brian Smith appeared in the absence of Alan Johnson and presented their monthly report with the complete report summary attached in the permanent file. Smith stated that the report includes a tree request at 61 Ridge Road. Wyatt asked when would they bring it down, and Smith said they just got request. McIntyre asked do we have to vote and Wyatt said if a citizen requests in writing, then no vote. Wyatt asked if have a jetter truck, what is the trailer. Smith responded that the truck requires a CDL license and trailer is good in right of ways, small areas and gives more flexibility.

Wyatt asked for any comments, Carter said that it sounds like a good idea. Owens said that she is on their board and so recluses herself.
- a. Tony Wyatt Mayor Pro tem said that he felt compelled to comment of a real miscarriage of justice during the last election. He said that he heard a story repeated that was so pervasive. The story was that Wetzel was compelled by SJWD to drop the law suit and sell the plant. You would first have to believe to have a breach of ethics. That he was with Donnie when he made his decision to run for Mayor and it was for the best interest of the Town. He then informed his management and would recluse himself from the lawsuit. If he was Mayor he does not the consent to sell without Council. Wyatt ended that he could not let these untruths go.


